Conditions of Summer School Financial Aid

1. AGNES SCOTT COLLEGE DOES NOT OFFER ANY INSTITUTIONAL FINANCIAL AID FOR SUMMER SCHOOL.
2. STUDENTS MUST BE ENROLLED FOR AT LEAST 6 CREDIT HOURS TO BE ELIGIBLE FOR ANY FINANCIAL AID.
3. Federal financial aid is only available during the summer to those students who have not utilized their entire 2019-2020 allotment of Federal Direct Stafford loans and/or Federal Pell grant.)
4. **Consortium Arrangement:** Students who have additional federal financial aid left over from the fall and spring terms and who attend approved courses at other eligible institutions during the summer may be eligible to receive some financial aid for their transient study through a Consortium Arrangement, available in the Office of Financial Aid.
 - Completion of a Consortium Arrangement is not a guarantee that summer school costs will be covered.
 - **Because of registration and payment deadlines at other schools, students must often pay in advance for their courses and be reimbursed when ASC is able to process any eligible financial aid. Please work with outside schools regarding their payment deadlines and charges.**
5. ZELL/HOPE Program recipients who attend other eligible Georgia schools during the summer may be eligible for some ZELL/HOPE scholarship funds via a ZELL/HOPE Transient Form. If you would like a ZELL/HOPE Transient Form completed on your behalf, please request one in the box on page 1.

NOTE:

- **ZELL/HOPE Transient forms are submitted only after spring grades are posted and ZELL/HOPE eligibility is checked.**
 - **NO future ZELL/HOPE Awards can be processed until all summer grades are submitted to and posted by the Agnes Scott College Registrar's Office.**
 - **ALL attempted hours will impact your 127 hours ZELL/HOPE Scholarship limit whether you receive HOPE funds or not.**
6. Summer school financial aid may not exceed Cost of Attendance.
 7. Students will be notified via e-mail, at the e-mail address provided on this form, what financial aid they might potentially be eligible for once the Summer School Financial Aid Application is processed.
