Your personal data will be transferred out of the European Union to Agnes Scott College located in the United States.

Your personal data will be stored in accordance with the record retention requirements applicable to Agnes Scott College and any other applicable U.S. laws. Under the EUGDPR, you have the right to request access to, rectify, erase and restrict the processing of your personal data. You also have the right to revoke this consent to use your personal data. If you feel the college has violated the EUGDPR, you have the right to file a complaint with the appropriate EU supervisory authority.
